The RSE "Kazvodkhoz" of Ministry of Water Resources and Irrigation of the Republic of Kazakhstan has received financing from the Islamic Development Bank (IsDB) toward the cost of the Project “**Climate Resilience Water Resource Development Project (Phase 1, Tranche 1)**” and intends to apply part of the proceeds toward payments under the contract for Construction of Karauzyak Reservoirs (Kyzylorda region)

2. The RSE "Kazvodkhoz" of Ministry of Water Resources and Irrigation of the Republic of Kazakhstan now invites sealed bids from eligible bidders for the **KAZ – 1030 CW-NCB - /01/04/ Construction of Karauzyak Reservoirs (Kyzylorda region)**. Construction reservoirs work comprise rehabilitation, strengthening and upgrading of the existing embankment dam and its appurtenant structures, including the dam body, upstream and downstream slopes, drainage and seepage control systems, crest structures and monitoring installations, with the objective of enhancing seepage control performance, drainage efficiency, structural stability, operational safety and instrumentation reliability. Bids will be evaluated package-wise and the contract will be awarded to the Bidder offering the lowest evaluated cost for the whole package. Details on the scope of work are provided in the bidding documents.

3. Bidding will be conducted through the National Competitive Bidding as specified in the “IsDB’s Guidelines for the Procurement of Goods, Works and Related Services under Islamic Development Bank Project Financing, April 2019 edition, revised in February 2023» and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.9.1-1.9.4, Part 01, Chapter 01 of Procurement Guidelines setting forth IsDB’s policy on conflict of interest.

4. Interested eligible bidders may obtain further information and inspect the bidding documents from the RSE "Kazvodkhoz" of Ministry of Water Resources and Irrigation of the Republic of Kazakhstan at the address below during office hours (09:00–17:00, UTC+5).

5. A complete set of bidding documents in English language may be received by interested bidders on the submission of a written application to the address below. The document will be sent by email.

6. Bids must be delivered to the address below by 15:00 Astana time on **10 September, 2026**. Bidders shall not have the option of submitting their Bids electronically. Bids will be opened immediately thereafter, in the presence of bidders’ representatives, who choose to attend, at the address below. Late bids will be rejected and returned unopened.
